- Take Exit 51 to Auburn, turn left onto South College Street
- At the intersection of College Street and East University Drive, turn right onto East University Drive
- At the intersection of East University Drive and Moore's Mill Road, turn right onto Moore's Mill Road
- Take first right after Regions Bank onto Rock Fence Road
- Take second right onto Fairway Drive
- Turn right into the Moore's Mill Club

From Atlanta

- Take I-85 South toward Montgomery
- Take Exit 57 toward Bent Creek Road, turn left onto Bent Creek Road
- At the stop light at the end of Bent Creek Road, turn right onto Hamilton Road
- At the next traffic light, turn right onto Moore's Mill Road
- After two blocks, turn left onto Rock Fence Road
- Take second right onto Fairway Drive
